RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-05-11-256 OF JOSEF D. NAVA, JR. & MARLENE T. NAVA ET-AL WITH TCT NO. T-162,634, LOT NO. 513 WITH A TOTAL AREA OF 2,326 SQUARE METERS MORE OR LESS, CONTAINING FIVE (5) LOTS LOCATED AT BRGY. BARROC, TIGBAUAN, ILOILO.

WHEREAS, the Subdivision Application of Josef Nava Jr. & Marlene T. Nava Et-Al with Subdivision Approval No. SA-05-11-256, With TCT No. T-162,634, Lot No. 513 With An Area Of 2,326 Square Meters More Or Less, Containing Five (5) Lots Located At Brgy. Barroc, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on June 19, 2012 for authorization and approval and also for revalidation of said Approved Subdivision Plan for the purpose of segregating lots intended for road right of way as recommended by Department of Public Works & Highways;

WHEREAS, the purpose/intent of this application is *to sell and to segregate lots intended for road right of way*;

WHEREAS, the said parcel of land is identified in the built-up area in the zoning classification;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plans;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
