RESOLUTION CONFORMING AND APPROVING THE CY 2012 SUPPLEMENTAL BUDGETS OF BARANGAYS BAGUINGIN AND CORDOVA SUR, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on July 12, 2012, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2012 Supplemental Budgets Embodying Appropriation Ordinance of Barangays:

Brgy. Cordova Sur CY 2012 General Fund Supplemental Budget No. 2012- 01, for CY 2012 involving An Appropriation Of P139,028.16, Approved By Sangguniang Barangay on July 10, 2012 and Enacted Under Appropriation Ordinance No. 2012-02;

Brgy. Baguingin CY 2012 General Fund Supplemental Budget No. 2012- 01, for CY 2012 involving An Appropriation Of P180,054.92 Approved By Sangguniang Barangay on June 15, 2012 and Enacted Under Appropriation Ordinance No. 2012-02;

WHEREAS, the Review of the foregoing Supplemental Budget embodying Appropriation Ordinance for CY 2011 of the afore-mentioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
