Resolution No. 2012-056

RESOLUTION DECLARING AS **VALID** BARANGAY BAGUINGIN ORDINANCE NO. 2012-002 PURSUANT TO SECTIONS 16 AND 391 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, after study and review by this Committee, the subject Barangay Ordinance was found out to be VALID and consistent with Sections 16 and 391 of R.A. 7160 of the Local Government Code of 1991, to wit:

SEC. 16. *General Welfare.* - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.crala

SEC. 391. *Powers, Duties, and Functions.* - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein;

- (14) Prescribe fines in amounts not exceeding One thousand pesos (P1,000.00) for violation of barangay ordinances;
xxx
- (24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.

WHEREAS, however, there is a need for amendment of the coverage of the ordinance as to time of implementation pursuant to Municipal Ordinance No. 92-004, entitled – "An Ordinance Prohibiting Minors to Wander, Saunter, Loiter, Or Truant on

Any Public Places After 10:00 P.M. And Before 4:00 A.M. And Providing Penalties In Violation Thereof”

Section 1. It shall be unlawful for any minor of any sex who is over nine (9) years but under eighteen (18) years of age to wander/saunter or loiter on any public or private streets, roads, alleys, park, plaza, wharf, public market, benches, public building, beaches, rivers, and parking places after 10:00 P.M., and before 4:00 A.M. This prohibition does not apply if such minor is accompanied by his par business certificate duly issued by the Municipal Mayor or his authorized representative, or if such minors may be found in such place of causes beyond his/her control upon excusable reasons;

NOW, THEREFORE, on motion of HON. JOSE DONEL T. TRASPORTO, Chairman, Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Agaton Tumabotabo, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, and Hon. Ricky Nulada,

RESOLVED, to declare As **Valid** Barangay Baguingin Ordinance No. 2012-002 Pursuant To Sections 16 And 391 Of The Local Government Code Of 1991,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Mayor James Excelsior M. Torres, to Brgy. Baguingin and all concerned for their information and/or appropriate action.
