RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-08-12-273 OF **INOCENCIA TABANG** WITH OCT NO. F-56877, LOT NO. 13005 WITH AN AREA OF 1,580 SQUARE METERS MORE OR LESS, CONTAINING FOUR (4) LOTS LOCATED AT BARANGAY BAGUMBAYAN, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of Inocencia Tabang with Subdivision Approval No. SA-08-12-273 With OCT No. F-56877, Lot No. 13005 With An Area Of 1,580 Square Meters More Or Less, Containing Four (4) Lots Located At Barangay Bagumbayan, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on August 29, 2012 for authorization and approval;

WHEREAS, the purpose/intent of this application is *to sell*;

WHEREAS, the said parcel of land is identified in the agricultural/residential area in the zoning classification;

- b.) Comply with all the corrections as indicated on the plans;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB;
