WHEREAS, the Subdivision Application of German Trasfiero with Subdivision Approval No. SA-08-12-274 With TCT No. T-18137, Lot No. 1624 With An Area Of 2,082 Square Meters More Or Less, Containing Three (3) Lots Located At Barangay Bagumbayan, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on August 30, 2012 for authorization and approval;

- This approval does not exempt the proponent from pertinent requirements of other government agencies;
- This approval does not exempt the proponent from securing registration and license to sell from HLURB;
