RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-08-12-276 OF **RODOLFO T. FRANCO ET- AL** WITH TCT NO. 0901211001251, LOT NO. 8-C WITH AN AREA OF 6,270 SQUARE METERS MORE OR LESS, CONTAINING FOUR (4) LOTS LOCATED AT BARANGAY 7, POBLACION, TIGBAUAN, ILOILO”.

WHEREAS, the Subdivision Application of Rodolfo T. Franco Et- Al with Subdivision Approval No. SA-08-12-276 With TCT No. 0901211001251, Lot No. 8-C With An Area Of 6,270 Square Meters More Or Less, Containing Four (4) Lots Located At Barangay 7, Poblacion, Tigbauan, Iloilo” with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on September 3, 2012 for authorization and approval;

WHEREAS, the purpose/intent of this application is *to sell*;

WHEREAS, the said parcel of land is identified in the residential area in the zoning classification;

WHEREAS, the conditions of said approval shall be the following:

- In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- Comply with all the corrections as indicated on the plans;
- Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- This approval does not exempt the proponent from pertinent requirements of other government agencies;
- This approval does not exempt the proponent from securing registration and license to sell from HLURB;
