**RESOLUTION CONFORMING AND APPROVING THE CY 2012 SUPPLEMENTAL BUDGETS OF BARANGAYS JAMOG AND CORDOVA NORTE, THIS MUNICIPALITY.**

WHEREAS, the Municipal Budget Officer on September 19, 2012 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2012 Supplemental Budgets Embodying Appropriation Ordinance of Barangays:

***Brgy. Jamog CY 2012 General Fund Supplemental Budget No. 2012- 01, for CY 2012 involving An Appropriation Of P29,247.44, Approved By Sangguniang Barangay on August 5, 2012 and Enacted Under Appropriation Ordinance No. 2012-02;***

***Brgy. Cordova Norte CY 2012 General Fund Supplemental Budget No. 2012- 01, for CY 2012 involving An Appropriation Of P87,434.89 Approved By Sangguniang Barangay on August 5, 2012 and Enacted Under Appropriation Ordinance No. 2012-02;***

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinance for CY 2012 of the afore-mentioned barangays likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters*) and duly seconded by Hon. Dennis Valencia, Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias, and Hon. Nyssa Nichola Callosa,
