**Resolution No. 2012-077**

RESOLUTION **REMANDING BACK** ORDINANCE NO. 4 S. 2012 OF BARANGAY BUYUAN, TIGBAUAN, ILOILO IN ORDER THAT THE SANGGUNIAN CONCERNED MAY AMEND THE SAME TO CONFORM WITH THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991, AND THE SUBMISSION OF THE AMENDED VERSION OF THE SAID ORDINANCE AFTER THE CONDUCT OF ANOTHER PUBLIC HEARING TO INFORM THEIR CONSTITUENTS OF THE AMENDMENTS MADE TO THE SAME.

WHEREAS, the above-mentioned subject matter was referred to the Committee for proper review and after careful study the committee found out that there is a need to amend the said ordinance as to its penalties.

WHEREAS, the said barangay ordinance adopted the provisions of Municipal Ordinance No. 92-004 of the Municipality of Tigbauan, but the Sangguniang Barangay failed to consider the limitations imposed upon it by law that it cannot impose imprisonment as a penalty for violations thereof. It can only impose fine as penalty as provided for under Section 391 (14) of R.A. 7160, to wit:

SEC. 391. *Powers, Duties, and Functions.* - (a) The sangguniang barangay, as the legislative body of the barangay, shall:

(14) Prescribe fines in amounts not exceeding One thousand pesos (P1,000.00) for violation of barangay ordinances;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Chairman, Committee on Rules, Ordinances, and Resolutions and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Dennis Valencia and Hon. Loreta Lungay-Arias,

RESOLVED, to **remand back** Ordinance No. 4 S. 2012 Of Barangay Buyuan, Tigbauan, Iloilo In Order That The Sanggunian Concerned May Amend The Same To Conform With The Provisions Of The Local Government Code Of 1991, And The Submission Of The Amended Version Of The Said Ordinance After The Conduct Of Another Public Hearing To Inform Their Constituents Of The Amendments Made To The Same,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. James Excelsior M. Torres, Municipal Mayor, this municipality, to Brgy. Buyu-an, and to all concerned for their information.
