RESOLUTION CONFIRMING AND APPROVING THE CY 2012 SUPPLEMENTAL BUDGETS OF BARANGAYS PARARA SUR, BINALIUAN MAYOR, BAGUMBAYAN, BITAS, BRGY. 6 (POB.) AND 2013 ANNUAL BUDGET OF BRGY. CORDOVA NORTE, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on November 8, 14 and 16, 2012 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2012 Supplemental Budgets Embodying Appropriation Ordinances of Brgys: Parara Sur, Binaliuan Mayor, Bitas and 6 (Poblacion), and 2013 Annual Budget and 20% Development Plan of Brgy. Cordova Norte:

Barangay Parara Sur General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P29,143.48, approved by Sangguniang Barangay on October 23, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Binaliuan Mayor General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P25,130.76, approved by Sangguniang Barangay on September 2, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Bagumbayan General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P102,141.94, approved by Sangguniang Barangay on October 1, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Bitas General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P80,628.00, approved by Sangguniang Barangay on August 5, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay 6 (Poblacion) General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P104,477.21, approved by Sangguniang Barangay on November 7, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Cordova Norte CY 2013 General Annual Budget Involving An Appropriation of P1,270,957.00 and 20% Development Fund in the amount of P250,391.40 Approved by Sangguniang Barangay on September 16, 2012 and September 26, 2012 respectively, and Enacted Under Appropriation Ordinance No. 2012-03.

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinances for CY 2012 and Annual Budget and 20% Development Plan of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental and Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental and Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, and Hon. Ricky Nulada,

RESOLVED, to conform and approve the CY 2012 Supplemental Budgets of Barangays Parara Sur, Binaliuan Mayor, Bagumbayan, Bitas, Brgy. 6 (Pob.) and 2013 Annual Budget of Brgy. Cordova Norte, this Municipality,
