RESOLUTION CONFIRMING AND APPROVING THE CY 2012 SUPPLEMENTAL BUDGETS OF BARANGAYS DORONG-AN, BUYUAN AND BRGY. 1 (POB.), THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on December 4, 2012 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2011 Supplemental Budgets Embodying Appropriation Ordinances of the said barangays:

Barangay Dorong-an General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P345,446.55, approved by Sangguniang Barangay on October 7, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay Buyu-an General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P53,199.64, approved by Sangguniang Barangay on November 17, 2012 and enacted under Appropriation Ordinance No. 2011-02.

Barangay 1(Poblacion) General Fund Supplemental Budget No. 2012-01 for CY 2012, involving an appropriation of P95,251.00, approved by Sangguniang Barangay on October 21, 2012 and enacted under Appropriation Ordinance No. 2011-02.

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinances for CY 2012 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by, Hon. Dennis Valencia, Hon. Alfonso Babiera, Hon. Elmer Torrato, Hon. Marlon Teruñez, and Hon. Ricky Nulada,
