**RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF NEW BATAAN, COMPOSTELA VALLEY IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00).**

WHEREAS, the onset of Tropical Storm Pablo, brought havoc to the Provinces of Compostela Valley, particularly the Municipality of New Bataan;

WHEREAS, the President of the Republic of the Philippines, His Excellency Benigno S. Aquino, through Proclamation No. 522 declared a State of National Calamity last December 7, 2012;

WHEREAS, as such, as one nation the Local Government Unit of Tigbauan wanted to extend Financial Assistance to the Municipality of New Bataan, Compostela Valley in the amount of One Hundred Thousand Pesos (P100,000.00) in order to hasten the rescue, relief, recovery and rehabilitation efforts of the local government;
