**Resolution No. 2012-082-A**

RESOLUTION REQUESTING THE MUNICIPAL MAYOR THROUGH THE HUMAN RESOURCE MANAGEMENT OFFICER THAT SANGGUNIANG BAYAN MEMBERS, MUNICIPAL PERSONNEL AND STAFF SHALL NOT BE ALLOWED TO GO ON FORCED LEAVE ANYMORE, FOR THE REMAINING WORKING DAYS OF THE YEAR 2012 AND HENCE, THEY SHALL NO LONGER BE DEDUCTED ANY UNUSED FORCED VACATION LEAVE FROM THE TOTAL ACCUMULATED VACATION LEAVE

WHEREAS, Rule XVI of the Omnibus Rules Implementing Book V, of E.O. No. 292, Sec. 25 provides that All officials and employees with 10 days or more vacation leave credits shall be required to go on vacation leave whether continuous or intermittent for a minimum of five (5) working days annually under the following conditions: x x x (b) The mandatory annual five-day vacation leave shall be forfeited if not taken during the year. However, in cases where the scheduled leave has been cancelled in the exigency of service, the head of agency, the scheduled leave not enjoyed shall no longer be deducted from the total accumulated vacation leave;

WHEREAS, the Office of the Sangguniang Bayan is burdened with workloads and paer works during the year end;

WHEREAS, the Sangguniang Bayan members and the Sangguniang Bayan Personnel and Staff have so manyu pending Committee Reports such as the 2013 Annual Budget deliberation, 20% Development Projects and Annual Investment Plan for CY 2013 and other Municipal Reports and related documents to work on before the year ends;

WHEREAS, it is imperative in the exigency of service, that the Sangguniang Bayan Members, Personnel and staff shall not be allowed to go on forced leave anymore, for the remaining working days of the year 2012 and hence, they shall be no longer deducted any unused forced leave form the total accumulated vacation leave;

NOW, THEREFORE, upon motion of HON. LORETA LUNGAY-ARIAS, and duly seconded by Hon. Dennis T. Valencia, Hon. Agonton Tumabotabo, Hon. Ricky T. Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to request Municipal Mayor through the Human Resource Management Officer that Sanggunian Bayan Members, Municipal Personnel and Staff shall not be alloed to fgo on forced leave anymore, for the remaining working days of the year 2012 and hence, they shall no longer be dedicted any unused forced vacation leave from the total accumulated vacation leave,

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, to Mrs. Luz Tronco, HRMO IV and to all concerned.
