RESOLUTION ENDORSING THE QUARRY PERMIT TO THE OFFICE OF THE PROVINCIAL GOVERNOR, PENRO, DENR, REGION VI AND THE BUREAU OF MINES AND GEOSCIENCES, FOR ORDINARY EARTH QUARRY APPLICATION AND FOR THE ENVIRONMENTAL COMPLIANCE CERTIFICATE FOR GLORA L. ACOSTA OF BARANGAY SIPITAN, TIGBAUAN, ILOILO

WHEREAS, on June 20, 2012 the Sangguniang Bayan, this municipality approved the application for the "EARTH QUARRY PROJECT" of Mr. Serafin Tabares on Lot No. 17239 located at Brgy. Sipitan, Tigbauan, Iloilo thru Resolution No. 2012-043;

WHEREAS, on August 2, 2012 Hon. Mayor James Excelsior M. Torres endorsed again another application for earth quarry of Mrs. Glora Acosta (on the same lot applied for by Mr. Serafin Tabares, Lot No. 17239) but this was rejected by the committee as per S.B. Committee Report No. 2012-041 dated August 17, 2012;

WHEREAS, in a Letter dated November 21, 2012 of Mrs. Glora L. Acosta to Hon. Ricky Nulada, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation, Mrs. Acosta requested for a resolution approving her earth quarry application with attached pertinent documents thereto;

WHEREAS, after a thorough investigation and checking all documents, the committee found out that the true and lawful owner of said parcel of land (Lot No. 17239) located at Brgy. Sipitan, this municipality is Mrs. Glora L. Acosta,

WHEREAS, the Municipality of Tigbauan, Iloilo has been a source for sand and gravel as well as earth materials, supplying both commercial and non commercial infrastructure development in the municipality, city and Province of Iloilo;

WHEREAS, Article 100 of the Local Government Code of 1991 empowers the Local Sangguniang Bayan to pass and endorse application permits for commercial sand and gravel as well as ordinary earth for the efficient protection and management of its natural resources;

WHEREAS, the allowance of the extraction of the ordinary earth at Barangay Sipitan, Tigbauan, Iloilo will enhance the economic condition and livelihood of the people living in the community as well as it will benefit the land owner for a better agricultural use;

NOW, THEREFORE, on motion of HON. RICKY T. NULADA, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias and Hon. Nyssa Nichola Callosa,

RESOLVED, to endorse the Quarry Permit To The Office Of The Provincial Governor, PENRO, DENR, Region VI And The Bureau Of Mines And Geosciences, For Ordinary Earth Quarry Application And For The Environmental Compliance Certificate For Glora L. Acosta Of Barangay Sipitan, Tigbauan, Iloilo,
