Resolution No. 2013-001

RESOLUTION DECLARING CLOSURE OF STREETS, OR ROADS WITHIN THE JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN NOT PURSUANT TO ANY ORDINANCE AS **ILLEGAL**, IN ACCORDANCE WITH SECTION 21 OF R.A. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, a letter dated January 4, 2013 was received by the Sangguniang Bayan from concerned citizens and taxpayers regarding the closure of the street fronting business establishments along Tejero Street, Tigbauan, Iloilo;

WHEREAS, the letter states among others that the closure of the said street hampers the access of customers and supplies to the affected establishments creating a bad business situations;

WHEREAS, Section 21. (RE: Closure and Opening of Roads), paragraphs (a) &(c) provides that:

- (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.
- (c) Any national or local road, alley, park, or square maybe temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and water works projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned;


WHEREAS, the Sangguniang Bayan of this municipality has not received any order from the Local Chief Executive requesting for the passage of an ordinance identifying the portion of the street to be closed as well as the duration of the closure;

WHEREAS, as far as the Sangguniang Bayan is concerned any closure of streets or roads without any ordinance is illegal and any obstruction or structure thereon should be removed;

NOW, THEREFORE, on motion OF HON. JOSE DONEL T. TRASPORTO, Chairman, S.B. Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Alfonso Babiera, Hon. Agaton Tumabotabo, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, and Hon. Ricky Nulada,

RESOLVED, to Declare the Closure Of Streets, Or Roads Within The Jurisdiction Of The Municipality Of Tigbauan Not Pursuant To Any Ordinance As Illegal, In Accordance With Section 21 Of R.A. 7160 Otherwise Known As The Local Government Code Of 1991.
