RESOLUTION REQUESTING THE CONCERNED MUNICIPAL OFFICIALS IN CHARGE WITH THE DISBURSEMENT OF FUNDS, TO RELEASE THE CLOTHING ALLOWANCE AND PRODUCTIVITY INCENTIVE BENEFITS INORDER THAT THESE EMPLOYEES CAN AVAIL OF SUCH BENEFITS SINCE THESE APPROPRIATIONS ARE ALREADY CONSIDERED AS REGULAR APPROPRIATION

WHEREAS, pursuant to DBM Circular No. 2012-1, all government workers are entitled to Uniform Clothing or Clothing Allowance in the amount of Five Thousand Pesos (P5,000.00) each which affirm the Aquino Administration's commitment to provide financial support to our country's public servants;

WHEREAS, Administrative Order No. 268, Series of 1991 provides for the grant of Productivity Incentive Benefits to full-time permanent, temporary and casual employees, including employees with employment in the nature of a regular employee, who have rendered at least one (1) year of service in the Government as of December 31, 1991;

WHEREAS, Uniform/Clothing Allowance and Productivity Incentive Benefits have long been considered as regular appropriations in the budget of the Municipality since every year these amounts are budgeted;

NOW, THEREFORE, on motion of HON. SUZETTE TENEFRANCIA-ALQUISADA, Chairperson, Committee on Appropriation, Budget, Finance and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Elmer Torrato and Hon. Loreta Lungay-Arias,

RESOLVED, to request the Concerned Municipal Officials In Charge With The Disbursement Of Funds, To Release The Clothing Allowance And Productivity Incentive

Benefits In order That These Employees Can Avail Of Such Benefits Since These Appropriations Are Already Considered As Regular Appropriation,
