**Resolution No. 2013-004**

**RESOLUTION CONFORMING AND APPROVING THE CY 2013 ANNUAL BUDGETS OF BARANGAYS BITAS, ATABAYAN, PARARA SUR, 3 (POBLACION) AND BAGACAY, THIS MUNICIPALITY.**

WHEREAS, the Municipal Budget Officer on January 3, 2013, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2013 Barangay Annual Budgets and 20% Development Plans, 5% BDRRMF of the following barangays:

***Barangay Bitas CY 2013 General Annual Budget Involving An Appropriation of P1,330,104.00, 20% Development Fund in the amount of P257,120.80, and 5% BDRRMF in the amount of P66,505.20 Approved by Sangguniang Barangay on December 2, 2012, and Enacted Under Appropriation Ordinance No. 2012-03.***

***Barangay Atabayan CY 2013 General Annual Budget Involving An Appropriation of P1,635,525.00, 20% Development Fund in the amount of P320,905.00, and 5% BDRRMF in the amount of P81,626.25 Approved by Sangguniang Barangay on November 3, 2012, and Enacted Under Appropriation Ordinance No. 2012-003.***

***Barangay Parara Sur CY 2013 General Annual Budget Involving An Appropriation of P1,530,337.00, 20% Development Fund in the amount of P301,667.40, and 5% BDRRMF in the amount of P76,516.85 Approved by Sangguniang Barangay on October 21, 2012, and September 23, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-03.***

***Barangay 3 (Poblacion) CY 2013 General Annual Budget Involving An Appropriation of P971,545.00, 20% Development Fund in the amount of P191,069.00, and 5% BDRRMF in the amount of P48,577.25 Approved by Sangguniang Barangay on October 21, 2012, and October 7, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-003.***

***Barangay Bagacay CY 2013 General Annual Budget Involving An Appropriation of P1,231,735.00, 20% Development Fund in the amount of P244,247.00, and 5%***

***BDRRMF in the amount of P61,586.75 Approved by Sangguniang Barangay on October 21, 2012, and December 9, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-002***

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets and 20% Development Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets and 20% Development Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Jose Donel Trasporto, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, and Hon. Nulada,

RESOLVED, to conform and approve the CY 2013 Annual Budgets Of Barangays Bitas, Atabayan, Parara Sur, 3 (Poblacion) and Bagacay, this Municipality,
