RESOLUTION CONFORMING AND APPROVING THE CY 2013 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF OF BARANGAYS LANAG, TARO, OLO BARROC, CANABUAN, JAMOG AND PARARA NORTE THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 18, 2013, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2013 Barangay Annual Budgets and 20% Development Plans, 5% BDRRMF of the following barangays:

***Barangay Lanag CY 2013 General Annual Budget Involving An Appropriation of P1,070,909.00, 20% Development Fund in the amount of P212,281.80, and 5% BDRRMF in the amount of P53,545.45 Approved by Sangguniang Barangay on September 16, 2012 and December 16, 2012 respectively, and Enacted Under Appropriation Ordinance No. 2012-003.***

***Barangay Taro CY 2013 General Annual Budget Involving An Appropriation of P784,538.00, 20% Development Fund in the amount of P155,007.60, and 5% BDRRMF in the amount of P39,226.90 Approved by Sangguniang Barangay on October 6, 2012 and October 14, 2012, and Enacted Under Appropriation Ordinance No. 2012-003.***

***Barangay Olo Barroc CY 2013 General Annual Budget Involving An Appropriation of P777,874.00, 20% Development Fund in the amount of P152,154.80, and 5% BDRRMF in the amount of P38,893.70 Approved by Sangguniang Barangay on October 14, 2012, and October 7, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-03.***

***Barangay Canabuan CY 2013 General Annual Budget Involving An Appropriation of P869,291.00, 20% Development Fund in the amount of P171,758.20, and 5% BDRRMF in the amount of P43,464.55 Approved by Sangguniang Barangay on October 6, 2012, and November 3, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-02.***

***Barangay Jamog CY 2013 General Annual Budget Involving An Appropriation of P890,773.00, 20% Development Fund in the amount of P175,854.60, and 5% BDRRMF in the amount of P44,538.65 Approved by Sangguniang Barangay on January 6, 2013, and December 2, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-001.***

***Barangay Parara Norte CY 2013 General Annual Budget Involving An Appropriation of P1,411,112.00, 20% Development Fund in the amount of P274,822.40, and 5% BDRRMF in the amount of P70,555.60 Approved by Sangguniang Barangay on January 6, 2013, and September 28, 2012, respectively, and Enacted Under Appropriation Ordinance No. 2012-001.***

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets and 20% Development Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets and 20% Development Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon.
