Resolution No. 2013-013

RESOLUTION AUTHORIZING HON. JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH (DOH), IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, ILOILO, AS RECIPIENT OF TB-DOTS ASSISTANCE FOR LGU'S UNDER CONDITIONAL CASH TRANSFER (CCT) PROGRAM OF THE NATIONAL GOVERNMENT

WHEREAS, in line with the objectives of the PhilPACT - to ensure provision of quality basic TB servicesin support to the improvement of health service delivery at the local level, the National TB Program (NTP) is sub-allotting funds to the CHDs for the use of LGUs on the provision of TB services and other public health-related programs;

WHEREAS, there are numerous municipalities, as determined by the DSWD for the Conditional Cash Transfer (CCT) program that need improvement on their basic services;

WHEREAS, the TB DOTS Center will also be assisted through these funds to improve their operations and to sustain quality of their daily operations to achieve DOTS certification and eventually become PhilHealth accredited. Such improvements shall also enable the health facilities to attain better client satisfaction;

WHEREAS, the service centers have to readily provide TB services to the population, especially the impoverished, to contribute to poverty alleviation. TB clients need to be assured of better health outcomes complemented with reduction from out-of-pocket costs;

WHEREAS, the municipality shall be allotted with Two Hundred Thousand Pesos (Php200,000.00) and shall be used for the following:

- (a) Needed repair of the health facility to enable this to conform with the standards for DOTS certification to include, but not limited to:
 - a.1 Improvement of patient's waiting area and DOT/Treatment corner
 - a.2 Improvement of sputum collection and/or microscopy section

- a.3 Improvement of storage area for proper management of TB drugs and other commodities
- (b) Provision of directional signage and location guides for easier patient flow
- (c) Augmentation of office supplies to ensure proper recording and needed record-keeping.

NOW, THEREFORE, on motion of **HON. ROEL T. JARINA**, Chairman, Committee on Health and Sanitation and duly seconded by Hon.Suzette Tenefrancia-Alquisada, Hon. Jose Donel Trasporto and Hon. Elmer Torrato,

RESOLVED, to authorize Hon. James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo To Enter Into A Memorandum Of Agreement (MOA) With The Department Of Health (DOH) In Behalf Of The Municipality Of Tigbauan, As Recipient Of TB DOTS Assistance For LGU's Under Conditional Cash Transfer (CCT) Program Of The National Government,

RESOLVED FURTHER, to furnish copies of this Resolution to Mayor James Excelsior M. Torres, this municipality, to DOH thru Nemesio T. Gako, MD, MPH, CESO II, Asst.
