**RESOLUTION CONFORMING AND APPROVING THE CY 2013 ANNUAL BUDGET, ANNUAL INVESTMENT PLAN, 20% DEVELOPMENT PLAN AND BDRRMF OF BARANGAY BANTUD, THIS MUNICIPALITY**

WHEREAS, the Municipal Budget Officer on March 1, 2013, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2013 Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of Barangay Bantud:

***Barangay Bantud CY 2013 General Annual Budget Involving An Appropriation of P794,281.00, 20% Development Fund in the amount of P156,836.20, and 5% BDRRMF in the amount of P39,714.05 Approved by Sangguniang Barangay on January 13, 2013 and December 2, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-01.***

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of the afore-mentioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Jose Donel Trasporto, Hon. Dennis Valencia and Hon. Loreta Lungay-Arias,

RESOLVED, to conform and approve the CY 2013 Annual Budget, Annual Investment Plan, 20% Development Plan and 5% BDRRMF Plan of Barangay Bantud, this Municipality,

RESOLVED FURTHER, to furnish copies of this Resolution to the following: Hon. Mayor James Excelsior M. Torres, OIC-Municipal Accounting Office, Municipal Budget Officer, Office of the Liga ng mga Barangay, and to Barangay Bantud, this municipality for their information and guidance.
