RESOLUTION CONFORMING AND APPROVING THE CY 2013 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF BARANGAYS 7 (POB.), NAPNAPAN SUR AND BARROC, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 14, 2013, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2013 Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of the following barangays:

Barangay 7 (Pob.) CY 2013 General Annual Budget Involving An Appropriation of P1,141,000.00, 20% Development Fund in the amount of P223,400.00, and 5% BDRRMF in the amount of P57,050.00 Approved by Sangguniang Barangay on February 13, 2013 and December 9, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-01.

Barangay Napnapan Sur CY 2013 General Annual Budget Involving An Appropriation of P1,228,004.00, 20% Development Fund in the amount of P236,200.80, and 5% BDRRMF in the amount of P61,400.20 Approved by Sangguniang Barangay on January 9, 2013 and December 8, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-01.

Barangay Barroc CY 2013 General Annual Budget Involving An Appropriation of P1,441,838.00, 20% Development Fund in the amount of P283,307.60, and 5% BDRRMF in the amount of P72,091.90 Approved by Sangguniang Barangay on February 3, 2013 and December 8, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-001.

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, and Legal Matters and duly seconded by Hon. Jose Donel Trasporto, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to conform and approve the CY 2013 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangays 7 (Pob.), Napnapan Sur and Barroc, this Municipality,
