WHEREAS, the Subdivision Application of Jesus T. Tagupa Et-Al with Subdivision Approval No. SA-01-13-281 With TCT No. T-12,497, Lot No. 3095 With An Area Of 809 Square Meters More Or Less, Containing Two (2) Lots Located At Barangay Parara Norte, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on March 12, 2013 for authorization and approval;

- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB;
