**RESOLUTION CONFORMING AND APPROVING THE CY 2013 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF BARANGAYS 9 (POB.), BUGASONGAN, DANAOS AND NAMOCON, THIS MUNICIPALITY.**

WHEREAS, the Municipal Budget Officer on April 4, 2013, endorsed to the Office of the Honorable Sanggunian Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2013 Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of the following barangays:

***Barangay 9 (Pob.) CY 2013 General Annual Budget Involving An Appropriation of P1,055,845.00, 20% Development Fund in the amount of P198,969.00, and 5% BDRRMF in the amount of P52,792.25 Approved by Sangguniang Barangay on January 27, 2013 and November 25, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-01.***

***Barangay Bugasongan CY 2013 General Annual Budget Involving An Appropriation of P730,566.00, 20% Development Fund in the amount of P144,328.20, and 5% BDRRMF in the amount of P36,528.30 Approved by Sangguniang Barangay on February 3, 2013 and December 1, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-01.***

***Barangay Danao CY 2013 General Annual Budget Involving An Appropriation of P829,658.00, 20% Development Fund in the amount of P163,931.60, and 5% BDRRMF in the amount of P41,482.90 Approved by Sangguniang Barangay on January 17, 2013 and December 23, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-001.***

***Barangay Namoccon CY 2013 General Annual Budget Involving An Appropriation of P1,472,075.00, 20% Development Fund in the amount of P283,015.00, and 5% BDRRMF in the amount of P73,603.75 Approved by Sangguniang Barangay on January 7, 2013 and December 17, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-001.***

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance and Legal Matters and duly seconded by: Hon. Jose Donel Trasporto, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Agaton Tumabotabo, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED, to conform and approve the CY 2013 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangays 9 (Pob.), Bugasongan, Danao and Namocon, this Municipality,
