WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provided for a meaningful participation of Non-Government Organizations, People's Organizations and Private Sectors in the pursuit of local autonomy and furtherance of development;

WHEREAS, the Code institutionalizes this participation through local special bodies which are primarily created and organized as the advisory and recommendatory bodies of the Local Government Units;

NOW, THEREFORE, on motion of Hon. Nyssa Nichola Callosa, Chairperson, Committee on Indigents and NGOs and duly seconded by Hon. Jose Donel Trasporto and Hon. Ricky Nulada,

RESOLVED, to call on All Community Based Organizations, People's Organizations, Non-Government Organizations As Well As Business And Professionals And Other Similar Aggrupations Whether Previously Accredited Or Seeking Accreditation For The First Time To Apply For Accreditation For Membership In Local Special Bodies Of The Municipality,

RESOLVED FURTHER, to furnish copies of this Resolution to all applicants of these organizations and the Office of the Municipal Mayor for their information and guidance.
