**Resolution No. 2013-040**

RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR, HONORABLE SUZETTE TENEFRANCIA-ALQUISADA TO AUGMENT ANY ITEM IN THE APPROVED CY 2013 ANNUAL BUDGET OF THE DIFFERENT OFFICES IN THE EXECUTIVE DEPARTMENT FROM SAVINGS IN THE PERSONAL SERVICES, MAINTENANCE & OTHER OPERATING EXPENSES AND CAPITAL OUTLAY OF THE SAME EXPENSE CLASS OF EXPENDITURES, PURSUANT TO SECTION 336 OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, presented for consideration of this August Body, under Urgent Measures, is the letter dated July 22, 2013 of the Municipal Mayor, Hon. Suzette Tenefrancia-Alquisada, requesting authority from the August Body to augment any item in the approved annual budget of the different offices from savings in the Personal Services, Maintenance & Other Operating Expenses and Capital Outlay of the same expense class of expenditures pursuant to Section 336 of the Local Government Code of 1991;

WHEREAS, there are some object of expenditures in the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay that have been exhausted and there are savings in other accounts of the same class of expenditures of the CY 2013 Annual Budget which are still available for appropriations;

WHEREAS, Section 336 of RA 7160 or the Local Government Code of 1991 empowers the Sanggunian to authorize the local chief executive to augment any item in the approved Annual Budget for their respective offices from savings in other items within the same expense class of expenditures of their respective appropriations;

WHEREAS, augmentation implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficit (Article 454(b)(2), IRR of RA 7160;

WHEREAS, priority shall be given to the personnel benefits of employees in the use of Personal Services savings.

WHEREAS, after proper and thorough deliberations on the subject matter, it was the consensus decision by the members of the August Body, to approve the aforesaid request;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriation and duly seconded by Hon. Jose Donel Trasporto, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Ricky Nulada and Hon. Nyssa Nichola Callosa,

RESOLVED To Grant Authority To The Municipal Mayor, Honorable Suzette Tenefrancia-Alquisada To Augment Any Item In The Approved Cy 2013 Annual Budget Of The Different Offices In The Executive Department From Savings In The Personal Services, Maintenance & Other Operating Expenses And Capital Outlay Of The Same Expense Class Of Expenditures, Pursuant To Section 336 Of The Local Government Code Of 1991.
