RESOLUTION DETERMINING THE MEMBERS OF THE PERSONNEL SELECTION BOARD OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO PURSUANT TO SECTION 80 OF THE LOCAL GOVERNMENT CODE OF 1991 TO ASSIST THE LOCAL CHIEF EXECUTIVE IN THE JUDICIOUS AND OBJECTIVE SELECTION OF LOCAL EMPLOYEES

WHEREAS, as per letter dated July 29, 2013, Mayor Suzette Tenefrancia-Alquisada, requested this August Body for the urgent passing of SB Board Resolution Determining The Composition Of The Personnel Selection Board, Tigbauan, Iloilo;

WHEREAS, Section 80 (b) of RA 7160 mandates every local government unit to establish a Personnel Selection Board (PSB) to assist the Local Chief Executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of policies which would contribute to employee's welfare in accordance with the Civil Service law and rules;

WHEREAS, pursuant to Section 80 (c) of RA 7160, the *Personnel Selection Board* shall be headed by the Local Chief Executive, and its members shall be determined by the resolution of the Sanggunian concerned. A representative of the Civil Service Commission, if any, and the personnel officer of the local government unit concerned shall be ex-officio members of the board;

WHEREAS, reasonable number of members may be added but the composition prescribed by CSC MC No. 3, s. 2001 may not be reduced and the PSB must be duly designated and names to be posted in the agency bulletin board;

WHEREAS, the representative for the 1st and 2nd Level positions in the Personnel Selection Board will be determined during election of TMEA Officers upon instruction of the Local Chief Executive;

WHEREAS, the Personnel Selection Board of the Municipality of Tigbauan shall therefore be composed of the following officials and employees:

- Chairman : Hon. Suzette T. Alquisada, *Municipal Mayor*
- Ex-Officio members : Mrs. Luz C.Tronco, *Supervising Administrative Officer*
- Members : Hon. Renee Librodo-Valencia, *Chairperson, S.B. Committee on Infrastructure, General Services & Civil Service*
- Representative, 1st Level Position
- Representative, 2nd Level Position
- Alternate Representative, 1st Level Position
- Alternate Representative, 2nd Level Position
- Department Head where vacancy exist

WHEREAS, a public office as constitutionally stated, is a public trust;

WHEREAS, the Personnel Selection Board shall serve their duties and functions with honesty, dignity and integrity as competent and honorable men working objectively and judiciously for the public and employee’s welfare;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA Chairperson, Committee on Civil Service and duly seconded by Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Ricky Nulada, Hon. Ronnie Paguntalan and Hon. Nyssa Nichola Callosa,

RESOLVED, to pass a resolution determining the members of the personnel Selection Board of the Municipality of Tigbauan, Province of Iloilo, pursuant to Section 80 of the Local Government Code of 1991 to assist the Local Chief Executive in the judicious and objective selection of local employees.

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor Suzette Tenefrancia-Alquisada, and to all concerned for their proper information and guidance.
