RESOLUTION AUTHORIZING HONORABLE SUZETTE TENEFRENCIA-ALQUISADA, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) PERTAINING TO THE IMPLEMENTATION OF THE ARTIFICIAL REEF PROJECT (JACKSTONE TYPE) AMOUNTING TO THREE HUNDRED SIX THOUSAND EIGHT HUNDRED TWENTY PESOS (P306,820.00)

WHEREAS, the Local Government Code of 1991 provides that LGUs shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction;

WHEREAS, the Bureau of Fisheries and Aquatic Resources (BFAR) is mandated to promote the development, improvement, management and conservation of the fisheries and aquatic resources in accordance with the Philippine Fisheries Code of 1998;

WHEREAS, the Artificial Reef Project (*concrete Jackstone-type*) aims to help in the restoration of the degraded marine resources and will facilitate succession and increase the number of species as it will provide habitat and breeding grounds for different marine species;

WHEREAS, the BFAR in cooperation with the Local Government Unit of Tigbauan will extend full support and cooperation in the implementation of the Artificial Reef Project (*concrete Jackstone-type*);

WHEREAS, BFAR will provide materials to be used in the construction of 250 units concrete jackstone-type Artificial Reef Project (ARs) in the amount of Php. 306,820.00, while the LGU will provide budget for the labor in the construction;

WHEREAS, Section 44-4(b)vi of the Local Government Code authorizes the Local Chief Executive, upon authorization by the Sangguniang Bayan, to represent the

municipality in all her business transactions and sign on her behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance;

NOW THEREFORE, on motion of Hon. Ronnie T. Paguntalan and was duly seconded by Hon. Renee Librodo-Valencia, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Ricky Nulada; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to Authorize Honorable Suzette Tenefrancia-Alquisada, Municipal Mayor, To Enter Into A Memorandum Of Agreement (MOA) With The Bureau Of Fisheries And Aquatic Resources (BFAR) Pertaining To The Implementation Of The Artificial Reef Project (Jackstone Type) Amounting To Three Hundred Six Thousand Eight Hundred Twenty Pesos (P306,820.00)
