**Resolution No. 2013-045**

RESOLUTION REQUESTING HON. SUZETTE TENEFRENCIA-ALQUISADA, MUNICIPAL MAYOR TO RE-ORGANIZE THE TASK FORCE TO MONITOR THE QUARRY OPERATIONS WITHIN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, there is an existing ordinance, Municipal Ordinance No. 2004-005 – *“AN ORDINANCE LEVYING INSPECTION AND MONITORING FEE ON TRUCK HAULING SAND AND GRAVEL, ORDINARY EARTH AND OTHER QUARRY RESOURCES FROM SIBALOM RIVER AS WELL AS PRIVATE AND PUBLIC LANDS IN THE MUNICIPALITY OF TIGBAUAN, ILOILO”*;

WHEREAS, although quarry operations within the Province of Iloilo is within the direct supervision and control of the Provincial Government, yet, its monitoring for compliance of the different mandated conditions is left to a Multi-Partite Monitoring Team;

WHEREAS, Section 9, Municipal Ordinance No. 2004-005 provides for the creation of Task Force Quarry under the Office of the Municipal Mayor to be composed of the following:
