RESOLUTION RESPECTFULLY REQUESTING THE GOOD GOVERNOR OF THE PROVINCE OF ILOILO, HONORABLE ARTHUR D. DEFENSOR, SR. FOR FINANCIAL ASSISTANCE FOR THE CONCRETING OF THE PROVINCIAL ROAD LOCATED AT THE RIGHT SIDE OF THE LIBERATION OF PANAY & ROMBLON LANDMARK, BARANGAY PARARA NORTE, TIGBAUAN, ILOILO.

WHEREAS, the Liberation of Panay & Romblon Landmark in the Municipality of Tigbauan, Iloilo is considered as a historical site which reminds our people of the heroism of Filipino and freedom fighters who successfully won the battle against Japanese invasion (*March 18, 1945*) is commemorated every 18th of March;

WHEREAS, the road located at the right side of the said historical landmark is part of the Parara-Jamog Road, classified as provincial road - is presently not in good condition and requires immediate repair and rehabilitation through concreting of the same;
