RESOLUTION CONFORMING AND APPROVING THE CY 2013 ANNUAL BUDGET, ANNUAL INVESTMENT PLAN, 20% DEVELOPMENT PLAN AND 5% BDRRMF PLAN OF BARANGAY SUPA, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer August 28, 2013, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2013 Barangay Supa Annual Budget, 20% Development Plan, and 5% BDRRMF Plan, to wit:

Barangay Supa CY 2013 General Annual Budget Involving An Appropriation of P814,200.00, 20% Development Fund in the amount of P160,640.00, and 5% BDRRMF in the amount of P40,710.00 Approved by Sangguniang Barangay on February 17, 2013 and December 9, 2012, respectively and Enacted Under Appropriation Ordinance No. 2013-001.

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of the afore-mentioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

sponsorship of Hon. Renee Librodo-Valencia, Committee Chairperson,) and duly seconded by Hon. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, and Hon. Nyssa Nichola Callosa,

RESOLVED, to conform and approve the CY 2013 Annual Budget, Annual Investment Plan, 20% Development Plan and 5% BDRRMF Plan of Barangay Supa, this Municipality,

RESOLVED FURTHER, to furnish copies of this Resolution to the following: Hon. Mayor Suzette Tenefrancia-Alquisada, OIC-Municipal Accounting Office, Municipal Budget Officer, Office of the Liga ng mga Barangay and to Barangay Supa, this municipality for their information and guidance.
