RESOLUTION COMMENDING THE TIGBAUAN PNP STATION PERSONNEL HEADED BY POLICE CHIEF INSPECTOR JANELO GEPANA FOR SUCCESSFULLY APPREHENDING MR. BALTAZAR SAN JOSE TIROL alias "*Balte*" DURING THE BUY-BUST OPERATION LAST SEPTEMBER 13, 2013

WHEREAS, a buy-bust operation was conducted on September 13, 2013 at around 5:05 in the afternoon by the *TIGBAUAN POLICE STATION* with the help of the *MEMBERS OF THE PROVINCIAL ANTI -ILLEGAL DRUGS SPECIAL OPERATIONS TASK FORCE, ILOILO POLICE PROVINCIAL OFFICE*, and the *1st MANEUVER PLATOON, ILOILO POLICE PROVINCIAL SAFETY COMPANY* at Sitio Campo Suerte, Tigbauan, Iloilo;

WHEREAS, said buy-bust operation led to the apprehension of MR. BALTAZAR SAN JOSE y TIROL alias "*Balte*" and the recovery and confiscation of elongated small heat sealed plastic sachet containing suspected shabu, one (1) small packed of suspected dried marijuana leaves, marked money and a nokia cell phone;
