**Resolution No. 2013-060**

RESOLUTION AUTHORIZING HON. SUZETTE TENEFRENCIA-ALQUISADA MUNICIPAL MAYOR OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE NATIONAL RED CROSS-ILOILO CHAPTER, FOR THE IMPLEMENTATION OF THE BLOOD SERVICE PROGRAM

WHEREAS, the Philippine Red Cross-Iloilo Chapter (PRC), is the designated “lead blood facility” in Western Visayas, licensed to operate as a blood center that will meet the needs of the community;

WHEREAS, the capability of the PRC Chapter to sustain its blood service operations is dependent upon community support for the blood donors and the availability of funds through the standard cost recovery fees approved by the Department of Health;

WHEREAS, the Municipality, in recognition of the indispensability of imposing the standard cost recovery fees herein undertakes to subsidize the same by setting aside an amount earmarked for assistance to indigents;

WHEREAS, for and in consideration of the foregoing premises and the terms and conditions hereunder enumerated, the parties to the agreement hereby agree that:

1. The Municipality shall:
  - a. Cause to be transferred the amount of Fifty Thousand Pesos (P50,000.00) to the Philippine Red Cross – Iloilo Chapter;
  - b. Said amount to cover patients exclusively referred to by the Office of the Honorable Mayor or his designated focal person using previously agreed upon referral form;
  - c. Undertake to replenish said amount upon its depletion; and
  - d. Schedule regular mobile blood drives in the Municipality.

2. The Chapter shall:
- a. Utilize the funds exclusively in accordance to the provisions of this agreement and rules that the parties herein will subsequently agree upon;
  - b. Submit a periodic accounting of the funds utilized;
  - c. Dispense the requisite blood subject to availability; and
  - d. Conduct regular mobile blood drives in the Municipality

This Memorandum of Agreement shall take effect immediately upon signing of the document by the official representatives of the Municipality of Tigbauan and the Philippine Red Cross – Iloilo Chapter and shall remain in force until sooner revoked or invalidated.

RESOLVED, to authorize Hon. Suzette Tenefrancia-Alquisada Municipal Mayor Of Tigbauan To Enter Into A Memorandum Of Agreement With The Philippine National Red Cross-Iloilo Chapter, For The Implementation Of The Blood Service Program,

RESOLVED FURTHER, to furnish copies of this Resolution to Mayor Suzette Tenefrancia-Alquisada, this municipality, Mr. Ramon Cua Locsin, Chairman, Philippine Red Cross-Iloilo Chapter and to all concerned for their information and/or appropriate action.
