**Resolution No. 2013-063**

RESOLUTION CONFIRMING THE DATE OF THE SCHEDULED BIDDING FOR THE SALUDAN FISHERY ZONE, THIS MUNICIPALITY WHICH IS SEPTEMBER 24, 2013 AT 1:30 IN THE AFTERNOON.

WHEREAS, Section 15 (*Time & Place of Auction*) of the Municipal Ordinance No. 2003-006 states that, *"The Sangguniang Bayan shall, in a resolution, provide for the holding of the public bidding for the granting of the concessions, lease or contracts, specifying the time, date and venue of such auction, the minimum bids, the amount to be deposited for entitlement to participate, the procedure to be followed by the committee, and the amount of bond as guaranty of good faith and for satisfactory compliance to the terms of the grant or license. The bond shall be in cash, in real estate situated within the Philippines, or by a surety company authorized for that purpose, in an amount equivalent to not less than two (2) years rental if for a three (3) year period at the maximum."*

WHEREAS, the bidding for Saludan Fishing Zone for the period of one (1) year from September 24, 2013 to September 24, 2014 thru public auction will be held at the Conference Room of the Municipal Building on September 24, 2013 at 1:30 in the afternoon with a minimum bid price of P30,000.00;

WHEREAS, the other provisions as required under Sec. 15 of the Municipal Ordinance No. 2003-006, follows the bids and awards procedures adopted in the preceding year;
