They are often formed among the disadvantaged sectors of society such as the farmer-peasant, artisanal fisherfolks, workers in the formal sector and migrant workers, workers in the informal sector, indigenous peoples and cultural communities, women, youth and students, children, senior citizens, victims of calamities and disasters, differently abled persons, urban poor as defined under Republic Act No. 8425 or the Social Reform and Poverty Alleviation Act of 1997;

WHEREAS, accreditation is a continuing process wherein a people's organization, non-government organization and business or professional group may apply and obtain accreditation at any time. The only legal effect of not applying for accreditation within the period prescribed by law and as reiterated in said DILG Memorandum Circular No. 2010-73, is that such organization is not entitled for representation in a local special body;
