RESOLUTION APPROVING THE APPLICATION FOR SUBDIVISION APPROVAL NO. SA-09-13-290 OF **DOLORES A. TAÑADA** WITH TCT NO. T-134236, LOT NO. 207-B-2-B, WITH AN AREA OF 7,768 SQUARE METERS MORE OR LESS, CONTAINING TEN (10) LOTS LOCATED AT BRGY. NAMOCON, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of **Dolores A. Tañada** with Subdivision Approval No. SA-09-13-290 With TCT No. T-134236, Lot No. 207-B-2-B, With An Area Of 7,768 Square Meters More Or Less, Containing Ten (10) Lots Located At Barangay Namoccon, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on September 25, 2013 for authorization and approval;

- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB;
