RESOLUTION APPROVING THE PURCHASE REQUEST FOR THE ACQUISITION OF TWO MOTOR VEHICLES FOR THE USE OF THE MUNICIPALITY OF TIGBAUAN FOR THE EFFICIENT AND EFFECTIVE DELIVERY OF SERVICES TO THE POPULACE

WHEREAS, in order to facilitate the efficient and effective delivery of services to our populace and to immediately respond to emergencies brought about by disasters and calamities it is necessary that serviceable motor vehicles of the municipality are readily available;

WHEREAS, Purchase Request No. 2013-049 (Annex A) dated August 20, 2013 for the procurement of one (1) unit Municipal Vehicle for the use of the office of the Mayor (Mayor's Car), and Purchase Request No. 13-048 (Annex B) dated August 20, 2013 for the procurement of one (1) Unit Municipal Vehicle for the use of MDRRMC as Rescue Vehicle for Disaster and Risk Management, have been approved by the Municipal Mayor;

WHEREAS, required funds for the acquisition of the motor vehicles specified under P.R. No. 2013-049 and P.R. No. 2013-048 have been appropriated as embodied in continuing appropriations for FY 2012 and the FY 2013 Annual Budget;

WHEREAS, Memorandum Circular No. 2013-047 dated June 3, 2013, of the Department of Interior and Local Government (DILG) provided for the Guidelines on LGU's Acquisition of Motor Vehicles Pursuant to AO No. 15, S. 2011;

WHEREAS, item No. 4.iii of said DILG Memorandum Circular No. 2013-047 requires that acquisition of motor vehicles by LGU's should have a corresponding Local Ordinance/Resolution;

NOW, THEREFORE, upon the request of the Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, on motion of Hon. Angelica Kilayco (counterpart of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations) and duly
