RESOLUTION EXTENDING FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FOR THE EARTHQUAKE VICTIMS OF BOHOL CHARGEABLE AGAINST THE 30% QUICK RESPONSE FUND UNDER THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND OF THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, the 7.2 magnitude earthquake brought chaos to the Island of Bohol last October 15, 2013, with 194 reported dead, 12 missing and 652 people injured as reported by the National Disaster Risk Reduction and Management Council (NDRRMC);

WHEREAS, the League of the Municipalities of the Philippines (LMP)- Iloilo Chapter agreed that all Municipalities in the Province of Iloilo shall extend financial assistance to the earthquake victims of Bohol in the amount of P50,000;

WHEREAS, this is our municipality's simple way of showing willingness to assist other LGUs especially in times of disaster or calamities and also to ease their burden as we show our care and concern as part and parcel of Filipino nation;
