RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA TO INFORM THE PHILIPPINE VETERANS BANK TO CONTINUE WITH ITS SERVICE OF PROVIDING FINANCIAL ASSISTANCE IN THE FORM OF SALARY LOANS TO QUALIFIED EMPLOYEES AND/OR OFFICERS OF THE MUNICIPAL GOVERNMENT OF TIGBAUAN AND TO SIGN DOCUMENTS RELEVANT TO EMPLOYEES' SALARY LOAN APPLICATIONS PURSUANT TO THE EXISTING MEMORANDUM OF AGREEMENT WITH THE SAID BANK.

WHEREAS, last October 11, 2013, the Philippine Veterans Bank, through Mrs. Leonila G. Tupino, sent a letter addressed to Hon. Suzette Tenefrancia-Alquisada for the ratification of the MOA with the said bank;

WHEREAS, on October 14, 2013, Atty. Suzette T. Alquisada, Municipal Mayor, sent a letter to the Members of the Sangguniang Bayan (*thru Hon. Roel Jarina, Vice Mayor*), requesting for the passing of a "*Resolution Ratifying The Existing Memorandum Of Agreement (MOA) By And Between Philippine Veterans Bank (PVB) And Municipality Of Tigbauan, Iloilo dated June 18, 2008*";

WHEREAS, on November 4, 2013, the Committee on Appropriations, (*to which said request was referred to*) rendered its **COMMITTEE REPORT No. 2013-050** and one of the committee's recommendations to which the members of this August Body has adopted on consensus was to authorize Mayor Suzette Tenefrancia-Alquisada:

- to inform the bank to continue with its service of providing financial assistance in the form of salary loans to qualified employees and/or officers of the Municipality of Tigbauan; and
- to sign documents relevant to employees' salary loan applications pursuant to the existing Memorandum of Agreement with the Philippine Veterans Bank.

RESOLVED, To Authorize The Municipal Mayor, Atty. Suzette T.
