RESOLUTION AUTHORIZING MAYOR SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF ILOILO, RELATIVE TO THE IMPLEMENTATION OF A SCHOLARSHIP PROGRAM ISSUED AS PER REQUEST OF CONGRESSWOMAN JANETTE L. GARIN, CHARGEABLE AGAINST FISCAL YEAR 2012 BUDGET RA 10155 AS PER SARO NO. BMB-G-13-00692 DATED MARCH 14, 2013, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN.”

WHEREAS, on October 14, 2013, Governor, Hon. Arthur D. Defensor, Sr., formally requested the Sangguniang Panlalawigan to authorize him to enter into a Memorandum Of Agreement between the Province of Iloilo and the Municipalities Of Tigbauan and Miag-ao, Iloilo, for the implementation of scholarship program issued per request of Congresswoman Janette L. Garin, chargeable against fiscal year 2012 Budget RA 10155 as per SARO No. BMB-G-13-00692 dated March 14, 2013 in the amount of One Million Six Hundred Ten Thousand Pesos (P1,610,000.00).

WHEREAS, the Provincial Legal Office opined that the said Memorandum Of Agreement is valid pursuant to Section 16 (*General Welfare*) in relation to Section 465 (b)(1)(vi) (*The Chief Executive: Powers, Duties, Functions, And Compensation*) of R.A. 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, The Province Of Iloilo and the Municipalities Of Tigbauan And Miag-ao are partners In the implementation of the said Scholarship Program within their respective jurisdictions, hence, the implementation thereof will be transferred to these municipalities which are in a better position to do the same;

WHEREAS, in view of the foregoing considerations, the Sangguniang Panlalawigan on October 17, 2013 passed Resolution No. 2013-268, “RESOLUTION AUTHORIZING THE GOVERNOR, HON. ARTHUR D. DEFENSOR, SR., TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE PROVINCE OF ILOILO, WITH THE MUNICIPALITIES OF TIGBAUAN AND MIAG-AO, RELATIVE TO THE IMPLEMENTATION OF A SCHOLARSHIP PROGRAM ISSUED AS PER REQUEST OF CONGRESSWOMAN JANETTE L.

GARIN, CHARGEABLE AGAINST FISCAL YEAR 2012 BUDGET IRA 10155 AS PER SARO NO. BMB-G-13-00692 DATED MARCH 14, 2013, IN THE TOTAL AMOUNT OF P1,610,000.00, SUBJECT TO ALL THE TERMS AND CONDITIONS STIPULATED THEREIN;”

WHEREAS, the parties to the said MOA agree on the following:

- A. THE PROVINCE OF ILOILO
- 1. Coordinate with the MUNICIPALITIES OF TIGBAUAN & MIAG-AO for the implementation of the program;
 - 2. Release and transfer the allocated amount of One Million Six Hundred Ten Thousand Pesos (P1,610,000.00) purposely for the implementation of the scholarship program for the identified schools within the said Municipalities of the 1st Congressional District of the Province of Iloilo;
- B. MUNICIPALITIES OF TIGBAUAN & MIAG-AO
- 1. a.) For the Municipality of Tigbauan - Receive and be responsible for the implementation, disbursement and liquidation of the amount of Seven Hundred Eighty Three Thousand Six Hundred Pesos (P783,600.00) intended for the scholarship program;
 - b.) For the Municipality of Miag-ao - Receive and be responsible for the implementation, disbursement and liquidation of the amount of Eight Hundred Twenty Six Thousand Four Hundred Pesos (P826,400.00) intended for the scholarship program;
 - 2. Prepare and submit all the required reports for the implementation of the above stated program.

That the said Agreement shall take effect on the date of the signing thereof by the parties concerned. Any modification or amendment to the said agreement shall be mutually agreed in writing by the parties.

Alquisada, For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With The Provincial Government Of Iloilo, Relative To The Implementation Of A Scholarship Program Issued As Per Request Of Congresswoman Janette L. Garin, Chargeable Against Fiscal Year 2012 Budget Ra 10155 As Per Saro No. Bmb-G-13-00692 Dated March 14, 2013, Subject To All The Terms And Conditions Stipulated Therein.”
