RESOLUTION APPROVING THE RE-PROGRAMMING OF THE AMOUNT OF THREE MILLION SEVEN HUNDRED EIGHTY THOUSAND PESOS (P3,780,000.00) FOR THE IMPLEMENTATION OF THE REHABILITATION OF DRAINAGE CANAL AT TEJERO ST., BARANGAY 3 AND 4 TO BE TAKEN FROM ITEM 8000-1-6 REHABILITATION OF MUNICIPAL ROADS, BRIDGES AND DRAINAGE SYSTEM IN THE ANNUAL INVESTMENT PLAN, 20% DEVELOPMENT PLAN FOR THE YEAR 2013”.

WHEREAS, on November 4, 2013, the Municipal Mayor, Atty. Suzette T. Alquisada formally indorsed to this August Body her request for the passage of a *“Resolution Approving The Re-Programming Of The Amount Of Three Million Seven Hundred Eighty Thousand Pesos (P3,780,000.00) For The Implementation Of The Rehabilitation Of Drainage Canal At Tejero St., Barangay 3 And 4 To be Taken From Item 8000-1-6 Rehabilitation Of Municipal Roads, Bridges And Drainage System In The Annual Investment Plan, 20% Development Plan For The Year 2013”*;

WHEREAS, as per attached *EXECOM-MDC RESOLUTION NO. 2013-02*, the amount of FOUR MILLION PESOS (P4,000,000.00) has already been identified in the Annual Investment Plan and 20% Development Plan for the year 2013, for the Rehabilitation of Municipal Roads, Bridges and Drainage System, of which P500,000.00 is for Drainage System of Tigbauan Public Market Rehabilitation, P3,000,000.00 for Municipal Roads asphaltting, and P500,000.00 for farm to market roads re-gravelling;

WHEREAS, in a series of discussion during previous sessions of the Sangguniang Bayan, it was pointed out that the priority project is the rehabilitation of the drainage canal;

WHEREAS, the Municipal Engineer has already presented to the Sangguniang Bayan the comprehensive drainage plan of the municipality with the total amount of P3,780,000.00 needed for the implementation of such project;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Infrastructure and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Ma. Gerrylin Santuyo - Camposagrado, Hon. Ricky Nulada and Hon. Ariel Bernardo;
