RESOLUTION APPROVING THE RE-PROGRAMMING OF THE AMOUNT OF FIVE MILLION SEVEN HUNDRED THOUSAND SIX HUNDRED TWELVE AND 80/100 PESOS (P5,700,612.80) TRUST LIABILITIES FOR MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND FROM 2010, 2011 AND 2012 BALANCES FOR THE ESTABLISHMENT OF 24-HOUR MDRRM OPERATION CENTER AND PROCUREMENT OF PRE AND POST DISASTER & CLIMATE CHANGE ADAPTATION MOTOR VEHICLE

WHEREAS, the Municipal Mayor, Atty.
