RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE DENNIS T. VALENCIA, BOARD MEMBER, PROVINCE OF ILOILO IN THE AMOUNT OF FOUR HUNDRED FORTY THOUSAND PESOS (P440,000.00) FOR THE GRAVELLING OF THE FOLLOWING FARM-TO-MARKET ROADS: BRGYS. ISIAN, CANABUAN, BINALIUAN MAYOR, BUENAVISTA, LANAG, OLO BARROC, BANTUD, SIPITAN, SITIOS NASULI, RIVERSIDE AND SAPA SAB-A, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO IN THE AMOUNT OF P40,000.00 EACH.

WHEREAS, the Municipality of Tigbauan is an agricultural municipality;
