Resolution No. 2013-091

RESOLUTION DECLARING AS LEGAL AND VALID OF BARANGAY BITAS ORDINANCE NO. 2013-001 - “ AN ORDINANCE REGULATING THE USE OF SOUND SYSTEM DURING PROGRAMS, BENEFIT DANCES, CULTURAL SHOWS AND OTHER SOCIAL FUNCTIONS OR GATHERINGS IN BARANGAY BITAS, TIGBAUAN, ILOILO AND PROVIDING PENALTIES IN VIOLATION THEREOF”

WHEREAS, the ordinance was referred to the Committee on Rules, Ordinances, Resolutions and Legal Matters for review and recommendation. In this regard, a committee meeting was conducted on November 28, 9:30 AM at the SB Session Hall which was attended by the Officials of Barangay Bitas, Tigbauan, Iloilo, the Chairman and Hon. Camposagrado, one of the Committee members.

WHEREAS, The committee found out that the above-mentioned ordinance is **VALID and LEGAL** pursuant to the following Sections 16, 139 (2), (14), (24), to wit it:

“SECTION 16. General Welfare. – Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, **maintain peace and order, and preserve the comfort and convenience of their inhabitants.**”

“SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;

- (14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;

- (24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;

WHEREAS, the same is also consistent with SECTION 16 of the LGC which provides every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion to the general welfare. Within their respective territorial jurisdictions, local government shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to balanced ecology, encourage and support development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;
