Resolution No. 2013-097

“RESOLUTION ENDORSING THE APPLICATION OF RS2 SOFTWARE ASIA (PHILIPPINES) FOR REGISTRATION OF IT’S BUSINESS SITE AT BARANGAY TAN PAEL, TIGBAUAN, ILOILO AS AN INFORMATION TECHNOLOGY (IT) PARK”

WHEREAS, RS2 Software Asia (Philippines), Inc. is a software consultancy firm with business address at Barangay Tan Pael, Tigbauan, Iloilo;

WHEREAS, in a letter dated November 19, 2013 addressed to the Hon. Suzette T. Alquisada, Municipal Mayor, RS2 thru its Administrative Assistant Ruth Sotto requested for an endorsement of its application for registration with the Philippine Economic Zone Authority (PEZA) of its business site at Barangay Tan Pael, this Municipality as an Information Technology (IT) Park;

WHEREAS, in a letter dated November 26, 2013, Hon. Mayor Suzette T. Alquisada endorsed the letter-request of RS2 to the Sangguniang Bayan of Tigbauan, Iloilo;

WHEREAS, during the regular session of the Sangguniang Bayan on December 2, 2013, the matter was referred to the Committee on Economic Affairs & Investment, chaired by Hon. Ariel Bernardo, for appropriate action;

WHEREAS, “INFORMATION TECHNOLOGY” (IT) is the collective term for the various technologies involved in the processing and transmitting of information, which include computing, multimedia, telecommunications, microelectronics and their interdependencies. It is also called “informatics” or “telematics”, the term “IT” is now also often used to refer to the convergence of various information-based, broadcast and mass media communication technologies. On the other hand, an “IT PARK” is an area which has been developed into a complex capable of providing infrastructures and other support facilities required by IT Enterprises (companies operating/offering IT services), as well as amenities required by professionals and workers involved in IT Enterprises, or easy access to such amenities (NITC 1997);

WHEREAS, the committee finds that the establishment of an IT Park at RS2 business area at Barangay Tan Pael would spur the growth of information technology

and economic enterprises in the Island of Panay and Region VI, more particularly in the locality of Tigbauan, Iloilo;

WHEREAS, RS2 Software Asia (Philippines) Inc. was granted business permit number 00109 (Receipt Number 1147312, dated January 17, 2013) to operate computer services at Barangay Tan Pael, Tigbauan,Iloilo. with Mrs. Serlinda P. Schaffter as operator;

WHEREAS, as per attached Zoning Certification dated December 3, 2013 issued by Mr. Ermin T. Sia, Municipal Zoning Officer, Lot 1255-B-6 where RS2 is situated is identified as a COMMERCIAL AREA;

WHEREAS, Sec. 447 of the Local Government Code of 1991 (RA 7160) provides that the Sangguniang Bayan, as a legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sec. 16 of the Code, as follows:

“SECTION 16. General Welfare. – Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.”

NOW THEREFORE, on motion of HON. ARIEL BERNARDO, Chairman, Committee on Economic Affairs & Investment and duly seconded by Hon. Virgilio Teruel, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno and Hon. Ricky Nulada,

RESOLVED, to favorably endorse the application for registration of RS2 SOFTWARE ASIA (PHILIPPINES), INC. with the Philippine Economic Zone Authority (PEZA) of its business site at Barangay Tan Pael, this Municipality, as an Information Technology (IT) Park subject to law and regulations;

RESOLVED FURTHER, to furnish RS2 SOFTWARE ASIA (PHILIPPINES), INC. and HON. SUZETTE TENEFRENCIA-ALQUISADA, Municipal Mayor, with copies of this Resolution.
