Resolution No. 2014-002

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. ATTY. SUZETTE TENEFRANCIA-ALQUISADA TO ENTER INTO A CONTRACT OF LEASE WITH THE MARKET STALL OWNERS AND LESSEES OF THE TIGBAUAN PUBLIC MARKET FOR AND IN BEHALF OF THE LGU OF THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, in a letter dated Dec 23, 2013, the Hon. Mayor Atty. Suzette Tenefrancia-Alquisada requested the Hon. Sangguniang Bayan to authorize her to enter into, for and in behalf of the LGU of Tigbauan into a Memorandum Of Agreement with the market stall owners and lessees of the Tigbauan Public Market;

WHEREAS, Municipal Ordinance No. 2010-007 of the Municipality of Tigbauan provides that the LGU shall enter into a contract of lease with the stall owners of the Tigbauan Public Market to protect the interest of the LGU and at the same time of the stall owners and holders;

WHEREAS, since the passage of Municipal Ordinance No. 2010-007, the LGU failed to come up with a contract of lease and consequently also failed to enter into one with the respective stall owners and holders in the Tigbauan Public Market;

WHEREAS, in order to correct this practice, and pursuant to the implementing rules and regulations particularly Rule 15 of the Local Government Code of 1991 specifically Article 87, Paragraphs B6, which provides: *"that upon authorization by the Sangguniang Bayan, the Municipal Mayor shall represent the municipality in all its business transactions and to sign on its behalf all bonds, contracts and obligations and such other documents made pursuant to law or ordinance"*, the Chairperson, S.B. Committee on Rules, Ordinances, Resolutions & Legal Matters, together with the Local Chief Executive, drafted a contract of lease, *which is hereto attached as ANNEX A and shall form as integral part of this resolution*;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Chairperson, Committee on Rules, Ordinances, Resolutions & Legal Matters, and duly seconded by Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Hon. Atty. Suzette Tenefrancia-Alquisada To Enter Into A Contract Of Lease With The Market Stall Owners And Lessees Of The Tigbauan Public Market For And In Behalf Of The LGU Of The Municipality Of Tigbauan;

RESOLVED FURTHER, to furnish copies of this Resolution to Mayor Suzette Tenefrancia-Alquisada for her appropriate action, and to all concerned for their information and guidance.
