**Resolution No. 2014-013**

RESOLUTION REQUESTING ASSISTANCE FROM THE ILOILO PROVINCIAL GOVERNMENT THROUGH THE HONORABLE GOVERNOR ARTHUR DEFENSOR SR. IN THE CONCRETING OF PARARA-JAMOG PROVINCIAL ROAD AT THE MUNICIPALITY OF TIGBAUAN

WHEREAS, the road connecting the barangays south of the Municipality of Tigbauan known as Parara-Jamog Road is classified as a Provincial Road of the Province of Iloilo;

WHEREAS, the Iloilo Provincial Government conducts regular maintenance works on said Parara-Jamog Provincial Road due to its rough condition, and has implemented partial concreting for the past years;

WHEREAS, only a portion said Parara-Jamog Provincial Road is concrete or cemented, and a greater portion remains rough;

WHEREAS, residents of nineteen (19) barangays of the fifty-two barangays of the municipality utilize the Parara-Jamog Provincial Road as their major thoroughfare to access the educational, health, commercial and other basic services and facilities;

WHEREAS, the rough and irregular condition of said Parara-Jamog Road has been a source of burden, discomfort and inconvenience to the residents of affected barangays especially during rainy reason;

WHEREAS, consistent with the promotion of the general welfare of the people and in order to alleviate their burden, discomfort and inconvenience it is best that said Parara-Jamog Provincial Road is concreted;

NOW, THEREFORE, through the motion of HON. RENEE L. VALENCIA, Chairman, Sangguniang Bayan Committee on Infrastructure, General Services and Civil Service, and duly seconded by Hon. Ma. Gerrylin Santuryo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,

RESOLVED, to request assistance from the Iloilo Provincial Government through the Honorable Governor Arthur Defensor Sr. in the concreting of Parara-Jamog Provincial Road at the Municipality of Tigbauan;
