**Resolution No. 2014-014**

RESOLUTION APPROVING THE HOLDING OF COCKFIGHTING AT BARANGAYS: BITAS, BAGUMBAYAN, DORONG-AN, BUENAVISTA, DAPDAP, BANTUD AND LUBOG, THIS MUNICIPALITY

WHEREAS, the following barangays have forwarded to this August Body their resolutions to wit:

- a.) Res. No. 2014-01 - *"RESOLUTION REQUESTING APPROVAL FROM THE HONORABLE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO TO HOLD A 2-DAYS COCKFIGHTING EVENT ON FEBRUARY 9 & 10, 2014 IN BARANGAY BITAS, TIGBAUAN, ILOILO",*
- b.) Res. No. 2014 – 02 –*"RESOLUTION REQUESTING THE HONORABLE SANGGUNIANG BAYAN MEMBERS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO TO ALLOW BARANGAY BAGUMBAYAN, TIGBAUAN, ILOILO, TO HOLD ONE (1) COCK DERBY AND HOCKFIGHT ON FEBRUARY 20-21, 2014 RESPECTIVELY IN LINE OF ITS ANNUAL FIESTA CELEBRATION ON FEBRUARY 24-25, 2014",*

- d.) Res. No. 2014—01 - *"RESOLUTION REQUESTING SANGGUNIANG BAYAN MEMBERS OF TIGBAUAN, ILOILO TO HOLD A COCKFIGHTING ON FEBRUARY 13, 2014 AT BARANGAY BUENAVISTA, TIGBAUAN, ILOILO THE NET PROCEEDS WILL BE USED TO BUY THE UNIFORMS IN OUR BARANGAY",*
- e.) Res. No. 2014-02 - *"RESOLUTION REQUESTING FOR APPROVAL OF THE HONORABLE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO TO HOLD A TWO (2) DAYS COCKFIGHTING EVENT ON FEBRUARY 14 -15, 2014 IN BARANGAY DAPDAP, TIGBAUAN, ILOILO",*
- f.) Res. No. 2014-02 – *"RESOLUTION REQUESTING THE APPROVAL OF THE HONORABLE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO TO HOLD A 2 DAYS COCKFIGHTING EVENT ON FEBRUARY 21 – 22, 2014 IN BARANGAY BANTUD, TIGBAUAN, ILOILO",*

g.) Res. No. 2014-001 – *“RESOLUTION TO HAVE A COCKFIGHTING ON FEBRUARY 21, 2014 FIESTA EVE CELEBRATION OF BARANGAY LUBOG, TIGBAUAN, ILOILO”*.

WHEREAS, on December 26, 2013, this August Body passed Municipal Ordinance No. 2013 – 005, entitled: *“AN ORDINANCE GRANTING A.P. TENDERO SPORTS ARENA-GALLERA DE TIGBAUAN, A FRANCHISE TO ESTABLISH, MAINTAIN AND OPERATE A COCKPIT IN THE MUNICIPALITY OF TIGBAUAN”*;

WHEREAS, on December 27, 2013 said ordinance was forwarded to the Sangguniang Panlalawigan for review and the same was returned and declared as legal and valid;

WHEREAS, Sec. 7.2, Sec. 7.3 & Sec. 7.4 of said ordinance provides:

**“Section 7.2.** In the absence of licensed cockpit in the barangay, cockfighting maybe allowed during the celebration of barangay annual fiesta for not more than three (3) days to be held in the place provided for cockfighting; Provided, however, that Sangguniang Bayan resolution and Mayor’s permit shall be secured prior to the scheduled cockfighting. In the event of conflict of schedule of cockfighting between the licensed cockpit and the barangay, the former shall prevail and the barangay cockfight shall be held before or after the scheduled cockfight in the licensed cockpit;

**Section 7.3** Prerequisites Of Holding Cockfighting In The Barangay. Barangay concerned shall be responsible in processing all the requirements needed in conducting cockfighting in the barangay. Two (2) weeks before the holding of cockfighting, concerned barangay shall pass a resolution addressed to the Sangguniang Bayan and copy furnished the cockpit franchisee for proper action and/ or approval. Only upon approval of the cockpit franchisee and the Sangguniang Bayan, the barangay shall process their Mayor’s permit and pay corresponding fees at the Municipal Treasurer’s Office.

**Section 7.4.** Only licensed cockpit personnel shall administer the cockfighting in the franchise cockpit and in every barangay fiesta celebration with the presence of one (1) personnel from the Municipal Treasurer’s Office.”

WHEREAS, this August Body hereby approves the conduct of such activity subject to compliance by the barangays concerned of the said ordinance particularly with regard to the aforementioned provisions;

WHEREAS, non-compliance of the requirements on the part of the barangay concerned shall be sufficient cause for the cancellation of this approval and/or legal action;

NOW, THEREFORE, on motion of Hon. Ronnie T. Paguntalan, Chairman, Committee on Brgy. Affairs and duly seconded by Hon. Jose Donel Trasporto, Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,

RESOLVED, to Approve The Holding Of Cockfighting At Barangays: Bagumbayan, Dorong-an, Bitas, Buenavista, Dapdap, Bantud, and Lubog, This Municipality.

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Mayor Suzette Tenefrancia-Alquisada, Municipal Mayor, to Brgys.: Bagumbayan, Dorong-an, Bitas, Buenavista, Dapdap, Bantud, Lubog and all concerned for their information and/or appropriate action.
