RESOLUTION REQUESTING ASSISTANCE FROM THE ILOILO PROVINCIAL GOVERNMENT THROUGH THE HONORABLE GOVERNOR ARTHUR DEFENSOR SR. FOR THE CONCRETING OF CORDOVA-BAROSONG PROVINCIAL ROAD AT THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the road connecting the barangays Cordova and Barosong, Municipality of Tigbauan and Barangay Mambong, Municipality of Leon known as Cordova-Barosong Road is classified as a Provincial Road of the Province of Iloilo;

WHEREAS, the Iloilo Provincial Government conducts regular maintenance works on said Cordova-Barosong Provincial Road due to its rough condition, and has not been concreted or cemented;
