**Resolution No. 2014-018**

RESOLUTION CONFORMING AND APPROVING THE CY 2014 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF BARANGAYS BANGKAL, OLO BARROC, LUBOG, TARO, BAGUMBAYAN, PARARA NORTE, JAMOG, CORDOVA NORTE AND CANSILAYAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 7, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2014 Barangays Bangkal, Olo Barroc, Lubog, Taro, Bagumbayan, Parara Norte, Jamog, Cordova Norte and Cansilayan Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans, to wit:

1. **Barangay Bangkal CY 2014 General Annual Budget Involving An Appropriation of P908,259.00, 20% Development Fund in the amount of P178,211.80, and 5% BDRRMF in the amount of P45,412.95 Approved by Sangguniang Barangay on December 21, 2013 and Enacted Under Appropriation Ordinance No. 2013-003;**
2. **Barangay Olo Barroc CY 2014 General Annual Budget Involving An Appropriation of P886,547.00, 20% Development Fund in the amount of P171,289.40, and 5% BDRRMF in the amount of P44,327.35 Approved by Sangguniang Barangay on October 13, 2013 and Enacted Under Appropriation Ordinance No. 2013-002;**
3. **Barangay Lubog CY 2014 General Annual Budget Involving An Appropriation of P933,500.00, 20% Development Fund in the amount of P181,798.20, and 5% BDRRMF in the amount of P46,675.00 Approved by Sangguniang Barangay on January 4, 2014 and December 8, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-001;**
4. **Barangay Taro CY 2014 General Annual Budget Involving An Appropriation of P881,411.00, 20% Development Fund in the amount of P174,542.20, and 5% BDRRMF in the amount of P44,070.55 Approved by Sangguniang Barangay on December 8, 2013 and December 15, 2013, respectively and Enacted Under Appropriation Ordinance No. 2013-003;**
5. **Barangay Bagumbayan CY 2014 General Annual Budget Involving An Appropriation of P1,505,166.00, 20% Development Fund in the amount of P296,233.20, and 5% BDRRMF in the amount of P75,258.30 Approved by Sangguniang Barangay on January 7, 2014 and December 16, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-01;**

6. **Barangay Parara Norte** CY 2014 General Annual Budget Involving An Appropriation of P1,593,781.00, 20% Development Fund in the amount of P311,156.20, and 5% BDRRMF in the amount of P79,689.05 Approved by Sangguniang Barangay on January 11, 2014 and December 24, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-001;
7. **Barangay Jamog** CY 2014 General Annual Budget Involving An Appropriation of P1,006,060.00, 20% Development Fund in the amount of P198,312.00, and 5% BDRRMF in the amount of P50,303.00 Approved by Sangguniang Barangay on January 5, 2014 and December 27, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-001;
8. **Barangay Cordova Norte** CY 2014 General Annual Budget Involving An Appropriation of P1,435,498.00, 20% Development Fund in the amount of P283,299.60, and 5% BDRRMF in the amount of P71,774.90 Approved by Sangguniang Barangay on January 5, 2014 and December 29, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-001;
9. **Barangay Cansilayan** CY 2014 General Annual Budget Involving An Appropriation of P832,150.00, 20% Development Fund in the amount of P163,950.00, and 5% BDRRMF in the amount of P41,607.50 Approved by Sangguniang Barangay on January 19, 2014 and Dec. 21, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-001;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, *Chairperson, Committee on Appropriations* and duly seconded by Hon. Ricky Nulada,

RESOLVED, to conform and approve the CY 2014 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangays Bangkal, Olo Barroc, Lubog, Taro, Bagumbayan, Parara Norte, Jamog, Cordova Norte and Cansilayan, this Municipality,
