RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, IN BEHALF OF THE LGU-TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE TIGBAUAN ATHLETIC CLUB (TAC) FOR THE MANAGEMENT OF THE 2014 SUMMER BASKETBALL LEAGUE IN THIS MUNICIPALITY.

WHEREAS, Atty. Suzette T. Alquisada, Municipal Mayor, in a letter dated February 24, 2014 to the Members of the Sangguniang Bayan (thru: Hon. Vice Mayor Roel T. Jarina), requested for the urgent passage of a *"Resolution Authorizing the Municipal Mayor to Enter Into A Memorandum of Agreement (MOA) with Tigbauan Athletic Club (TAC) for the Conduct of 2014 Summer Basketball League in the Municipality of Tigbauan".*

WHEREAS, the **ROLES AND RESPONSIBILITIES** of both parties as stated in the said MOA shall be as follows:

Local Government Unit:

a.) The Office of the Mayor shall supervise the conduct of the 2014 Summer Sports League;

b.) The Purchase of sports equipments needed of the 2014 Summer Sports League shall be in accordance with the existing budgeting, accounting and auditing rules and regulations;

c.) The LGU shall monitor the implementation of the sports program of the municipality.

Tigbauan Athletic Club (TAC):

a.) Manage the conduct of 2014 Summer Sports League in so far as basketball games are concerned;

b.) Responsible for the scheduling of games;

c.) Monitor and respond to urgent concerns of the LGU as to the conduct of the games

WHEREAS, the finance and accountability provisions of the said MOA is hereby held in abeyance and shall accordingly be subjected to further specification and determination of the actual sharing of expenses between parties taking into consideration all aspects of financial management as well as existing laws, rules and regulations as to the release of public funds to facilitate a clearer delineation of responsibilities;

Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,

RESOLVED to Authorize The Municipal Mayor, In Behalf Of The LGU-Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With The Tigbauan Athletic Club (TAC) For The Management Of The 2014 Summer Basketball League In This Municipality with reservation as to finance and accountability provision;
