## Resolution No. 2014-025

RESOLUTION CONFORMING AND APPROVING THE CY 2014 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF BARANGAYS ALUPIDIAN, POBLACION I, BAYUCO, BUYU-AN AND BINALIUAN MAYOR, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 24, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2014 Barangays Alupidian, Poblacion I, Bayuco, Buyu-An, Bainaliuan Mayor Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

- **1.** Barangay Alupidian CY 2014 General Annual Budget Involving An Appropriation of *P855,856.00, 20%* Development Fund in the amount of *P169,371.20,* and 5% BDRRMF in the amount of *P42,792.80* Approved by Sangguniang Barangay on December 14, 2013 and December 7, 2013, respectively and Enacted Under Appropriation Ordinance No. 2013-003;
- 2. **Barangay Poblacion I** CY 2014 General Annual Budget Involving An Appropriation of *P1,200,928.00,* 20% Development Fund in the amount of *P226,585.60,* and 5% BDRRMF in the amount of *P60,046.40* Approved by Sangguniang Barangay on January 8, 2013 and December 22, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-01;
- 3. **Barangay Bayuco** CY 2014 General Annual Budget Involving An Appropriation of *P940,003.00, 20% Development Fund in the amount of P184,800.60, and 5% BDRRMF in the amount of P47,000.15 Approved by Sangguniang Barangay on January 5, 2014 and December 5, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-01;*
- 4. **Barangay Buyu-an** CY 2014 General Annual Budget Involving An Appropriation of *P1,993,127.00,* 20% Development Fund in the amount of *P394,225.40,* and 5% BDRRMF in the amount of *P99,656.35* Approved by Sangguniang Barangay on January 20, 2014 and December 23, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-01;
- 5. **Barangay Binaliuan Mayor** CY 2014 General Annual Budget Involving An Appropriation of *P1,309,229.00,* 20% Development Fund in the amount of *P258,945.80,* and 5% BDRRMF in the amount of *P65,461.45* Approved by Sangguniang Barangay on January 12, 2014 and December 12, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-01;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, *Vice Chairman, Committee on Appropriations* and duly seconded by Hon. Ma. Gerrylin Santuyo- Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,
